- ELIGIBILITY: A current, up-to-date Membership card from one of the art leagues of ACSWF
- ENTRY FEES: A non-refundable of \$40 for the first entry, \$20 for second entry, for a maximum of two entries per artist, payable to the Art Council of Southwest Florida. (ACSWF)
- EXHIBITION DATES: Wednesday, April 1 through Friday, May 1
- ENTRY INSTRUCTIONS: Registration online opens February 15 and ends March 15 (at 5 pm)
- FEE: You must pay at the time of online registration with a credit card
- RECEIVING: Monday, March 30, 2 – 4 pm. **PLEASE NOTE: THERE WILL BE NO REGISTRATION FORMS OR PAYMENTS ACCEPTED AT RECEIVING.**
- POST SHOW PICKUP: All artwork must be removed promptly on Saturday, May 2, between 10 am and 12, noon.

A \$5 per day fee will be charged for any artwork left at the gallery. If you are unable to pick up your art yourself, you may assign someone to pick it up for you. They must have a note, signed by the artist, giving them permission to pick it up.

AWARDS: Awards are given separately for 2D and 3D winners

2D: 1st \$300 2nd \$200 3rd \$100

3D: 1st \$300 2nd \$200 3rd \$100

Peoples' Choice Award \$50 (to be announced at the end of show)

RECEPTION: Wednesday, April 1, 5 – 7 pm. Small bites and beverages will be available.
Awards announced at 6:30.

EXHIBITION: All artwork must be original and completed by the artist within the past five (5) years. Works that have been in or eligible for the Winners Circle Show, may not be entered.

MEDIA: Two-D and Three-D works may be entered, including, but not limited to: Photography, Batik, Paintings and Drawings in any medium, Clay, Collage, Fiber Art, Glass, Jewelry, Metal, Mixed Media, Paper, Sculpture, Serigraphs, Stone, Weavings and Wood.

2-D ARTWORK: Maximum size for both pieces together must be no larger than 2099 sq. in. including frames.

Paintings on canvas less than 1 ½ inches in depth must be framed. Paintings on 1 ½" deep stretched canvas may be framed or have sides neatly painted and no staples showing.

Diptych will be considered one entry and must be hung together, and not exceed 30x30 inches. It will be judged as a whole, and be judged as one piece. Entry forms and paintings must be noted "Diptych" and include the order of hanging.

All 2-D artwork must be wired with ends of wire covered with tape. Wire when pulled to hang, must be 3 inches from the top of painting. D-rings that hold the wire, must be totally secure. Screw eyes are not allowed. Matts, frames, glass or plexiglass should be cleaned, not marred or scratched. Identifying labels (found in Entry/Waiver) must be attached to the back of the artwork.

3-D ARTWORK: Identifying labels (found in Entry/Waiver) must be adhered to the back or the artwork. Artists admitting jewelry must include appropriate stands. Jewelry will be displayed in locked glass cases during the show.

The weight for 3-D artwork is limited to 60 pounds. If the sculpture disassembles for transportation, no section may weigh more than 60 pounds.

EXCLUSIONS: The Art Council of Southwest Florida reserves the right to exclude any work with subject matter or presentation deemed inappropriate.

SALES: All sales will be handled by Coco Art Gallery of Naples. A sales tax of 6% will be added to the listed price. The artists' share of the sale is 70%, with Coco Art Gallery/ACSWF retaining 30% as commission. Artists should price their work accordingly.
